Purpose: The Employment Security Department currently runs three programs: State Unemployment Insurance, WA Cares, and Paid Family and Medical Leave. As part of its duties, the Department receives payments from employers for each program. Occasionally, an employer sends a payment to the Department without indicating which program(s) the payment was intended for, and the Department is unable to make contact with the employer. There are currently no rules addressing how employer payments are allocated across these programs in these situations. Therefore, the Department is adopting new rules that address how payments will be allocated across these programs.
