Youth Empowerment Program Minutes

Friday, September 5, 2025 10:00 AM to 11:00 AM

<u>Minutes</u>: Nancy made a motion to accept the meeting minutes and Lucas seconded the motion. All voted in favor. Motion passed and minutes approved as written.

- 1. Guest speaker, Lilah Wakefield from Washington State Legislative Youth Advisory Council (LYAC). Lilah shared the following information about the program.
 - LYAC works with the Lt. Governor, and the students create questions, setup
 meetings to go through applications, interviews, choose final applicants for the
 cohort. All LYAC youth make the decisions.
 - For recruitment: Office of Superintendent of Public Instruction (OSPI) gave
 LYAC a list of all principals in Washington state and LYAC sent a recruitment
 email to all of them
 - LYAC has a strong social media presence including Instagram and limited
 TikTok. They used videos created with Canva.
 - They answer lot of real-time questions

- Students are allowed to participate in LYAC during school hours. They need to communicate with teachers and get their schoolwork done.
- LYAC members must be in high school when they serve their term and have an
 option to apply for second term. They want to give as many students as possible
 the opportunity to be on the committee.
- LYAC has weekly 1–2-hour online meetings and are given duties to complete.
 Subcommittees have checklists with students. Students can be put on suspension if they are not participating. Lilah will send us OSPI contact person.
- LYAC's budget comes from the Lt. Governor's office. They have been in a budget crisis for the last two legislative sessions.
- LYAC has four in-person meetings per year. They are reimbursed for transportation and food. For the Legislative Action Day, member's transportation (flight to SeaTac Airport), hotel and food are covered.
- Legislation is important to youth. Last year, they championed quite a few bills.
 SB 5132: Mandatory reporting for sexual assault. It didn't pass in committee.
 SB 5030: Using inclusive language in documents. A bill for kindergarten allowing more than passport or birth certificate for enrolling in school. It failed in House.
 This year they will choose 3-4 priorities and bills must stay within those priorities.
- 100 students attended the Legislative Action Day last year
- Covid protocol. LYAC didn't require masks or social distancing on Action Day.
 They encouraged hand washing and asked members not to come if they were sick.
