# 1: Welcome to the Employment workgroup meeting - call to order - Yvonne Bussler-White

Meeting called to order by presiding Chair Yvonne Bussler-White at 9:02am (pulling up agenda), welcomed all, excited to continue the work. Folks are doing well, about to be doing some travelling.

## 3: Housekeeping rules – Yvonne Bussler-White

## 4: Planning activities - Yvonne/all

- a. Recap of actions/assignments proposed at last meeting:
  - **Review of CEA flyer:** Thank you to Amy for reviewing the CEA flyer. **Please note,** as it did not originate from GCDE, we cannot suggest edits. We just wanted to know whether to share it out with our list can we decide now? **Folks agree, Elizabeth will let CEA know.**
  - Reaching out to HRC in support: for possible request legislation or a decision package if
    desired, and inviting them to join a meeting? Elizabeth reached out about something
    else and didn't hear back, she will follow up. Note: Agencies have been looking at cuts
    and not additional funding.
  - Resource guide/Eastern WA: Steven, Brit, and Yvonne had not connected as of when agenda was drafted due to bandwidth issues for Yvonne, she did research, but couldn't find addtl. resources for Eastern WA (difficult). Brit pulled up the guide they & Steven had been working, on and explained the categories for statewide and local resources. Amy had a suggestion for Whatcom Co. We could consider adding County Bar Associations (list), which includes addtl. Eastern WA counties (link). Please review for any additions, then we can send to staff for review of next steps.

- NDEAM blurbs: Thank you to Amy for reviewing. They have started going out weekly on the GCDE Facebook page as of 10/1, and are receiving engagement (likes, shares). Will continue.
- Federal impacts: We need to keep abreast of federal impacts. DVR and DSB are advocating in congress for protections around cuts to special education, birth to 3 programs, RSA services/priority wait lists and pulldown funding/budget ramifications etc. We might need to consider focusing on all services for PWD, not just employment. DOH discussed WIC cuts recently (no allotment prior to shut down, funding may run out start of next week). Could be ongoing/intentional. Will affect DD, BH, CRPs etc. We may need to mention at GM. Elizabeth will ask for more info on Medicaid waivers impact. We'll learn more in the next few weeks reach out with any new info to guide next steps.

- HRC: Elizabeth reached out about something else and didn't hear back, so will follow up. Note that agencies may be looking at cuts rather than addtl. funding currently.
- **Resource guide:** We will consider adding the county bar associations (list on link), to include addtl. Eastern WA resources, then share w/ staff for review/next steps.
- **NDEAM blurbs:** Thanks for review. These have been going out weekly on Facebook (Wednesday's at noon), receiving engagement, and will continue (Oct.)
- **Federal impacts:** We need to keep abreast of these changes. We may consider focusing on all svcs. for PWD, not just employment, and possibly mention at GM. Elizabeth will ask for more info on impacts to Medicaid waivers. All, please reach out with any new info to guide next steps.
