**Purpose:** The Employment Security Department is adopting new rules and amendments regarding the Long-Term Services and Supports Trust Program (WA Cares Fund) to implement a portion of Substitute House Bill 2467, which passed into law during the 2024 legislative session. The adopted rules implement a portion of the bill that was codified in RCW 50B.04.180 by defining "out-of-state participant." The adopted rules also add additional program definitions, outline qualified individual requirements and determinations, and further align the WA Cares Fund and Paid Family and Medical Leave appeals processes.
