# Unemployment Insurance Division – UI Tax and Wage administration Multiple employer tax rate – file specifications Sept. 1, 2023

## Instructions

Your request for tax rates for multiple employers must be in the following format. We will validate the supplied Employment Security Department (ESD) Number, Federal ID Number and UBI Number of each request (two of the three requested numbers must match our system for us to provide rates; the ESD Number is required).

Each line within your file must end with a carriage return/line feed (Hex: OD OA or OA OD).

The file must not contain "Low Values" (Hex: 00).

## What's new (July 1, 2022)

Employment Security Department changed its numbering system from nine to 12 digits. The numbering system also has a different name – Employment Security Department (ESD) Number.
